Terms and Conditions:

1. The School shall not be eligible at any time to be taken over by the Government.
2. The School shall abide by Rules and regulations, Guidelines, Curriculum and Syllabus prescribed by the Department which is amended from time to time.
3. The School shall promptly reply to any information sought by the Department and should be kept open for inspection to Departmental Officers.
4. The School Shall have required land area i,e 1(one) Acre or more for further up-gradation of classes.
5. The School shall constitute a Managing Board as per norms prescribed by the Department.
6. This renewal of provisional recognition holds no obligation for grant-in-aid.
7. The School shall not be allowed to up-graded without prior permission from the competent authority.
8. The School shall re-apply for renewal of recognition after 3(three)years from the date of issuing this order if the School does not want further up-gradation. Failing to do so ,late fine shall be charge.
9. The school shall appoint qualified B.Sc M.Sc for Science & Maths teachers.
10. Any School failing to comply with the terms & conditions shall result to cpcancellation of recognition.
